



SCHOLARSHIP 2021

DEADLINE EXTENDED TO MAY 17, 2021

Description: Six scholarships are awarded to provide financial assistance to **2021 graduating high school seniors** whose parents/guardians or the student are members of First Financial Credit Union.

Additional scholarships are awarded to continue providing financial assistance to **past First Financial scholarship recipients** who have maintained a 2.0 GPA and are current members or whose parents/guardians are members of First Financial Credit Union. Past recipients that remain full-time students are eligible for a total of five (5) consecutive years while earning an Associates or Undergraduate degree.

All scholarships are to be used to attend a **New Mexico institution** of higher learning.

Basis of Awards: The scholarships will be awarded based on the financial need of the student applying.

Value of Awards: Each scholarship is for \$1,500.00 to be awarded at \$750.00 per semester for two (2) semesters.

Eligibility: Parent/guardian or student must be a member of First Financial Credit Union. Immediate family members of volunteers and staff are not eligible.

Student must be a graduating senior in good standing, planning to attend a two (2) or four (4) year accredited New Mexico College or University, or any prior year First Financial scholarship recipient currently enrolled at a New Mexico institution of higher learning.

Student must be enrolled as a full-time student with a minimum of 12 hours.

Student must have at least a 2.0 average.

Application

CHECK EACH ITEM AS COMPLETED:

- Completed application form.
- A personal letter from the applicant indicating why assistance is needed.
- Three (3) letters of reference. All should be from a non-relative and from an instructor, counselor, principal or employer.
- Transcript of previous high school or institution of higher learning, including latest semester.
- Divorced individuals or parents must provide a copy of divorce decree and/or child support information.
- List any other financial assistance that the student has applied for or is receiving (FAFSA, Pell grants, student loans, other scholarships, etc.).
- List any unusual financial circumstances, i.e., medical bills, unusually large debt, childcare, etc., and include copy of bills or proof of unusual needs.
- A COPY OF PARENT'S AND SELF (if applicable) **W2s FOR THE YEAR 2020 MUST ACCOMPANY THIS APPLICATION.**
- A COPY OF PARENT'S AND SELF (if applicable) **ENTIRE TAX FORM FOR THE YEAR 2020 AS SUBMITTED TO THE IRS, INCLUDING ALL SCHEDULES AND OTHER SUPPORTING INFORMATION NOTED ABOVE, MUST BE POSTMARKED NO LATER THAN FRIDAY, APRIL 16, 2021. MONDAY, MAY 17, 2021**

Income Verification Requirements:

Student **must** provide copies of parent(s) and individual income tax returns (1040). **These must be signed copies of what was sent to the IRS. Student must also provide supporting documents for any income reported on tax forms.** Please provide any of the following that apply to you. If you have income that is not listed below, please provide supporting documentation for that income also.

- **W2s** to verify wages.
- **1099-SSA** to verify social security benefits.
- **1099-INT** to verify interest income.
- **1099-R** to verify retirement pensions and annuities.
- **1099-DIV** to verify dividend income.
- **1099-G** to verify unemployment compensation.
- **1099-MISC** to verify miscellaneous income, if any.
- **Schedule B**
- **Schedule C or C-EZ** to verify business income or loss.
- **Schedule D** to verify capital gain or loss.
- **Schedule E** to verify rental real estate, royalties, partnerships, S corporations, trusts, etc.
- **Form 4797** to verify other gains or losses.

****Applications may not be considered if any of the above items are missing or are incomplete.****
